It is intended to be used together with EN ISO 4254-1:2009 *"Agricultural machinery — Safety — Part 1 : General requirements (ISO 4254-1:2008)"* and EN 15811:2009 *"Agricultural machinery — Guards for moving parts of power transmission — Guard opening with tool (ISO/TS 28923:2007 modified)"*."

Delete the current 6th paragraph:

"This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive."

Delete the current 8th paragraph:

"This standard has been developed to support the Machinery Directive 2006/42/EC."
